ALL that piece, parcel or lot of land, situate, lying and being in the County of Greenville, State of South Carolina, being shown and designated as Lot No. 20 on a plat entitled "Stratton Place" by Piedmont Engineers and Architects dated July 10, 1973, and recorded in Greenville County Plat Book 4-R at Pages 36-37, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at the right of way line of Providence Court at the joint front corner of Lots 19 and 20 and running thence with the joint line of Lot 19, N. 66-28, W. 151.25 feet to an iron pin at the joint rear corner of Lots 19 and 20; thence turning and running with the rear line of Lot 20, N. 25-16 E. 125 feet to an iron pin on the right of way of Providence Square; thence turning and running with the right of way of Providence Square, S. 67-46 E. 135.0 feet to an iron pin; thence turning and running S. 21-53 E. 34.8 feet to an iron pin at the intersection of Providence Court and Providence Square; thence continuing with the right of way of Providence Court, the cord of which is S. 24-00 W. 50 feet to an iron pin; thence continuing with Providence Square, the cord of which is S. 36-00 W. 55 feet to the point of BEGINNING.
