the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto GREENVILLE COUNTY SEWER AUTHORITY, its successors and assigns:

ALL that certain piece, parcel or tract of land situate, lying and being in Greenville County, State of South Carolina, containing .93 acres, more or less, as shown on plat entitled "Lagoon Site, Greenbrier Elementary School", dated June 12, 1974, prepared by Campbell & Clarkson, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin 600 feet from a point on Log Shoals Road and running thence N. 29-30 W. 161.2 feet to an iron pin; thence N. 60-17 E. 250.6 feet to an iron pin; thence S. 29-43 E. 161.9 feet to an iron pin; thence S. 60-29 W. 251.3 feet to the point of beginning.

It being a portion of the consideration of this conveyance that if and when the within described property ceases to be used for sewer purposes, the same shall automatically revert back to the School District of Greenville County.
