REAL PROPERTY AGREEMENT

In consideration of such loans and indebtedness as shall be made by or become due to THE CITIZENS AND SOUTHERN HATIONAL BANK OF SOUTH CAROLINA (hereinafter referred to as "Bank") to or from the undersigned, jointly or severally, and until all of such loans and indebtedness have been paid in full, or until twenty-one years following the death of the last survivor of the undersigned, whichever first occurs, the undersigned, jointly and severally, promise and agree

- 1. To pay, prior to becoming delinquent, all taxes, assessments, dues and charges of every kind imposed or levied upon the real property described below; and
- 2. Without the prior written consent of Bank, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein; and
- 3. Hereby assign, transfer and set over to Bank, its successors and essigns, all monies now due and hereafter becoming due to the undersigned, as rental, or otherwise, and howsoever for or on account of that certain real property situated in the County of Greenville State of South Carolina, described as follows:

All that lot of land situate on the west side of Charlbury Street in the City of Greenville, County of Greenville, S. C. being known as Lot No. 16 on plat of Section F of E Gower Estates, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book JJJ page 99 on plat made by R.K. Campbell and Webb Surveying and Mapping Co. November 1965, and having according to said plat the follow ing metes and bounds to wit:

BEGINNING at an iron pin on the West Side of Charlbury Street at the joint front corner of Lots 16 and 17 and runs thence along the line of Lot 17 S. \$64-31 W. \$9! 199.4 feet to an iron pin; thence S. 19-23 E. 105.5 feet to an iron pin; thence N. 70-08 E. 215.4 feet to an iron pin; thence N. 19-52 W. 1.25 feet to an iron pin on the south edge of a turn around on Charlbury Street; thence with the curve of Charlbury Street(the chord being N. 59-00 W. 65 feet) to an iron pin; thence still with the curve of Charlbury Street (the chord being N.7-09 E. 54.2 feet) to an iron pin; thence still along Charlbury Street N. 19-56 W. 25 feet to the beginning corner.

and hereby irrevocably authorize and direct all lessees. escrow holders and others to pay to Bank, all rent and all other monies whatsoever and whensoever becoming due to the undersigned, or any of them, and howsoever for or on account of said real property. and hereby irrevocably appoint Bank, as attorney in fact, with full power and authority, in the name of the undersigned, or in its own name, to endorse and negotiate checks, drafts and other instruments received in payment of, and to receive, receipt for and to enforce payment, by suit or otherwise, of all said rents and sums, but agrees that Bank shall have no obligation so to do, or to perform or discharge any colligation, duty or liability of the undersigned in connection therewith.

- 4. That if default be made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to Bank when due, Bank, at its election, may declare the entire remaining unpaid principal and interest of any obligation or indebtedness then remaining unpaid to Bank to be due and payable forthwith
- 5. That Bank may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Bank, in its discretion, may elect.
- 6. Upon payment of all indebtedness of the undersigned to Lank this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and source to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
