McGOWAN, JR., as Master, in and for the County of Greenville aforesaid, by virtue of the aforesaid decree, and in consideration of \$5,300.00 and assumption of mortgage recited below, HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said James Walter Tripp and Betty G. Tripp:

ALL that piece, parcel or lot of land, situate, lying and being on the northwestern side of Arthur Avenue, in the City of Greenville, County of Greenville, State of South Carolina, being shown and designated as Lot 18, Block L on plat of Property of O.
