WINN, an undivided 10.1449% of my interest in and to the property hereinafter described, and an undivided 10.1449% interest to WILLIAM C. WRIGHT of my interest in the property hereinafter described, their heirs and assigns forever:

All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the southerly side of East North Street, in the City of Greenville, South Carolina, and having according to a plat entitled "Property of John C. Winn, et al." made by Campbell & Clarkson Surveyors, Inc., dated July 31, 1974, recorded in the RMC Office in Plat Book 5H, page 18, and having according to said plat the following metes and bounds, to-wit:
