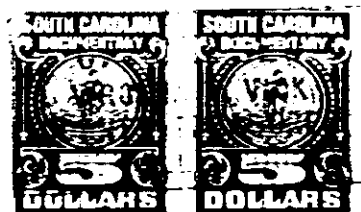
In consideration of Five Thousand and no/100 (\$5,000) -----Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto W. C. Murrell, Falbia C. Murrell, and Maggie M. Murrell, their heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being on the western side of Stoney Point Drive, near Grove Road, near the City of Greenville, in Greenville County, South Carolina, being shown and designated as the northern portion of a tract of land contain 0.48 acres entitled Survey for Luther G. Murrell by Piedmont Engineers and Architects dated April 10, 1970 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the western side of Stoney Point Drive, (shown on the above referred to plat as Dirt Road) at the corner of property now or formerly owned by Maggie Roach and running thence with the line of said Roach property, S. 80-01 E. 138.0 feet to a point; thence leaving said Roach property and running with the line of Property of Martin, S. 9-29 E. 35 feet to a point; thence leaving the Martin line and running in an easterly direction approximately 133 feet to a point on the western side of Stoney Point Drive; thence with the western side of Stoney Point Drive, N. 6-48 E. 88.8 feet to the point of beginning. - 156 - 100 - 1 - 6.4
