and release unto WOODROW F. STEWART AND MAUREEN T. STEWART, their heirs and assigns
forever;

ALL that piece, parcel, or lot of land, with the buildings and improvements thereon, in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as a portion of Lot No. 31, Section C, Stone Land Company, a plat of which is recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book A, Page 341, and having according to a survey by Campbell and Clarkson, dated February 24, 1969, captioned Property of Grady K. Ashe, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Croft Street, which iron pin is 270.75 feet from the southeast intersection of Croft Street and Robinson Street, and running thence S 1-41 W. 200 feet to an iron pin on the northern side of a 16 foot alley; thence with the northern side of said alley, S. 83-13 E. 54 feet to an iron pin in the rear corner of Lot No. 33; thence with the line of Lot No. 33, N. 1-41 E. 200 feet to an iron pin on the southern side of Croft Street; thence with the southern side of Croft Street, N. 83-13 W. 54 feet to the point of beginning.

This conveyance is made subject to all easements, rights-of-way, zoning ordinances, and restrictions affecting the property.

Being the same conveyed to the grantor by deed recorded in said R. M. C. Office in Deeds Book 910, Page 458.

As part of the consideration hereof, the grantees assume and agree to pay the balance on the promissory note executed by the grantor to C. Douglas Wilson & Co., dated February 28, 1969, secured by mortgage recorded in said R.M.C. Office in Mortgage Book 1118, Page 305, on which there is a balance of \$14,376.94
