ALL that tract of land in the County of Greenville, State of South Carolina, approximately three miles from Travelers Rest, South Carolina, and near South Carolina Highway 25, shown as a 10.75 acre tract of land on a plat of the property of H. K. Townes Estate, made by J. Mac Richardson, RLS, July, 1958; and having, according to said plat, the following metes and bounds:
