in consideration of Two Thousand, Five Hundred and No/100----- Dollars,

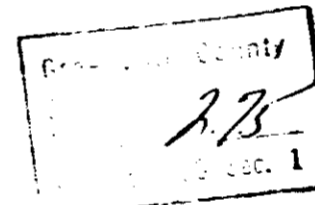
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Joe P. McKee, his heirs and assigns forever: All my right, title, and interest, the same being a one-third interest, in and to the following described real estate:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the West side of the Buncombe Road, near the City of Greenville, being known as Lot No. 9 of Block A, on plat of Property of Mountain View Land Company, recorded in the R. M. C. Office for Greenville County in Plat Book "A" at Page 396, and being described as follows:

BEGINNING at a pin on the West side of Buncombe Road, corner of Lot No. 8, and running thence with the line of said lot 183 feet to a stake on a 10 foot alley; thence with the East side of said alley in a Northerly direction 45 feet to a stake, corner of Lot No. 10; thence with the line of said lot 180 feet to a pin on the Buncombe Road; thence with the Western side of the Buncombe Road in a southeasterly direction 60 feet to the beginning corner; less, however, a strip conveyed off the front of said lot to the South Carolina State Highway Department used to widen said highway.
