the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto  
W. E. LONG, His Heirs and Assigns, Forever:

ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot No. 233 and 234 as shown on a plat of Section No. 2, Caroline Court, dated November, 1953, by Dalton & Neves, recorded in the RMC Office for Greenville County in Plat Book GG, at Page 21, and having according to said plat the following description, to wit:

BEGINNING on Marlana Avenue at the turn-around at joint front corner of Lots 232 and 233 and running thence 215 feet with the side line of Lot 232 to iron pin at joint rear corner of Lots 232 and 233 and side line of Lot 186; running thence 132.9 feet with side line of Lot 186 to iron pin at joint rear corner of Lots 186 and 233; running thence 277.9 feet, more or less, with rear line of Lot 233, according to recorded plat, to iron pin at joint rear corner of Lots 233 and 234; continuing thence 309 feet, more or less, with rear line of Lot 234, according to recorded plat, to an iron pin; running thence 335 feet with side line of Lot 234 to iron pin at joint rear corner of Lots 234 and 235; running thence 229.1 feet with side line of Lot 235 to iron pin at joint front corner of Lots 234 and 235 on Marlana Avenue; running thence 141.4 feet with line of said turn-around on Marlana Avenue to iron pin at joint front corner of Lots 232 and 233 on Marlana Avenue, the point of beginning.
