All that certain piece, parcel, or tract of land situate, lying and being in the State of South Carolina, County of Greenville, near Mauldin, S. C., on the southeastern side of Log Shoals Road, being shown as three tracts, one containing 8.57 acres, one containing 1.27 acres, and one containing 10.85 acres, being shown on the plat entitled "Property of Nannie Marler Abercrombie Estate" prepared by C. O. Riddle, R. L. S. dated February, 1974 and revised March 15, 1974, being recorded in the R. M. C. Office for Greenville County in Plat Book 5H, at Page 27, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an old iron pin in the center of Log Shoals Road at its intersection with Griffin Road, and running thence with Griffin Road, S. 45-31 E. 416.3 feet to an old iron pin on the northwest side of Griffin Road at the corner of property of Neoma G. Cunningham; thence with the line of her property, N. 38-52 E. 1853.6 feet to an old iron pin; thence with the line of property of Bobbie F. and Lewis Charles Hayes, Sr., N. 39-02 E. 1238.2 feet to an old iron pin in the line of property of J. O. Shaver; thence with the line of said property, N. 69-08 W. 67.1 feet to an old iron pin; thence N. 69-00 W. 467.2 feet to an old iron pin; thence S. 5-19 E. 209.9 feet to an old iron pin; thence N. 68-54 W. 232.3 feet to an iron pin on the southeastern side of Log Shoals Road; thence continuing N. 68-54 W. approximately 25 feet to a point in the center of Log Shoals Road; thence with the center of said road, the following courses and distances: S. 4-19 E. approximately 300 feet to a point, S. 2-04 E. 100 feet, S. 3-58 W. 100 feet, S. 11-58 W. 100 feet, S. 17-28 W. 100 feet, S. 23-58 W. 100 feet, S. 29-24 W. 100 feet, S. 34-23 W. 100 feet, S. 40-48 W. 200 feet, S. 43-11 W. 160 feet, S. 47-49 W. 400 feet, S. 48-06 W. 571 feet, S. 47-57 W. 140 feet; thence N. 45-53 W. 36 feet to an old iron pin on the northwestern side of Log Shoals Road; thence S. 43-39 W. 359.4 feet to the -130-0070E 573.1-1-5 beginning corner.
