All that certain piece, parcel, or lot of land in the City of Greenville, County of Greenville, State of South Carolina on the westerly side of Paris View Drive (formerly West Fairview Avenue), being shown as Lot No. 13, on plat of Druid Hills, made by Dalton and Neves, Engineers, in January, 1947, and having the following metes and bounds, to wit:
