BEGINNING at an iron pin on the westerly side of Paris View Drive (formerly West Fairview Avenue), joint front corner of Lots Nos. 12 and 13, said pin being 140.4 feet south from southwest corner of intersection of Paris View Drive and West Hillcrest Drive and running thence along line of Lot No. 12, N. 77-36 W. 100 feet to an iron pin; thence along the rear line of Lot No. 10, S. 39-38 W. 82.5 feet to an iron pin; thence with line of Lot No. 14, S. 73-38 E. 138.9 feet to an iron pin on the westerly side of Paris View Drive; thence with the westerly side of said Drive, N. 16-22 E. 44.9 feet to an iron pin; thence continuing along said Drive, N. 6-32 E. 35.1 feet to the point of BEGINNING.

The within conveyance is subject to restrictions of record, and is also subject to utility easements and rights-of-way of record or on the ground, along with tap fees, set back lines, and zoning regulations.

As a part of the consideration, grantee assumes and agrees to pay the balance due on that certain mortgage from Shelley Realty & Construction Co., Inc. and Betty M. Burket to Carolina Federal Savings and Loan Association of Greenville, said mortgage being in the original amount of \$11,900.00, dated 28 September 1972, recorded 29 September 1972, RMC Office for Greenville County, S.C., in Mortgage Book 1251, at Page 241, upon which there is a present balance due of approximately \$11,500.00.
