TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, Willie A. Jones County Treasurer of said Greenville County, did issue his warrants directed to the Delinquent Tax Collector for said County and State by authority of the acts of the General Assembly of South Carolina and the statute laws of said State, against J. A. & Mattie Jane Loftis, Est., defaulting taxpayer(s) of said County, strictly charging and commanding said Delinquent Tax Collector of said County to levy by distress and sale of the lands of the said J. A. & Mattie Jane Loftis, Est., tax defaulter(s), the sum of Seven Hundred Thirty & No/100 Dollars including the penalties on said tax execution(s) for the year(s) 1970, 1971 & 1972 together with charges and costs thereof; and

WHEREAS, by virtue and authority of said warrants George F. Miller the delinquent tax collector of the State and County aforesaid, did on the 14th day of May 19 73 seize and take exclusive possession of the said property against which said taxes were assessed and levied, as hereinafter described, and on Sales Day of the month of June during the usual hours of sale, after due advertisement, sell the same to Willie A. or Vera M. Jones and their heirs and assigns, the purchaser(s), hereinafter known as "grantee(s)," and the highest bidder at such sale, for the sum of \$730.00 and gave a receipt for said purchase money to them; and

WHEREAS, more than twelve months have elapsed since the date of said sale, and the defaulting taxpayer(s), or any other party interested, have failed to redeem said land so sold for taxes;

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS That I, George F. Miller, Tax Collector of and for the County and State aforesaid, in consideration of the premises, and the sum of Seven Hundred Thirty & No/100 Dollars to me paid by the said grantee(s), Willie A. or Vera M. Jones

have granted, bargained, sold and released, and by these presents do grant, sell, bargain and release unto the said grantee(s), Willie A. or Vera M. Jones

their heirs and assigns:

All that certain lot of land known as Lot 2, Millervale Road and shown on the County Block Book Map as Sheet 535.2, Block 1, Lot 27, and described on said map as follows:

Beginning at an iron pin on the Southwest side of Millervale Road at the joint front corner of Lots 1 and 2 and running thence in a Westerly direction 145 feet to an iron pin and thence along the rear line of Lot 2 in a Southerly direction 50 feet to the joint rear corner of Lots 2 and 3, thence in an easterly direction 146.3 feet to an iron pin on Millervale Road thence in a Northwesterly direction along Millervale Road 50 feet to the beginning Point.
