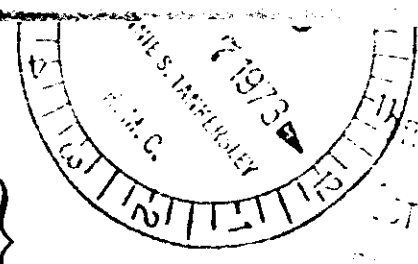

All that piece, parcel or lot of land in the County of Greenville, State of South Carolina, being shown and designated as Tract No. 5 on a plat of property of Grover C. Clark, by J. C. Smith, RLS, made August, 1952, recorded in Plat Book DD, page 17 of the RMC Office for Greenville County, South Carolina, and having such metes and bounds as shown thereon.

This conveyance is made subject to easements and right-of-way of record including the right of way for S. C. Highway No. 418.

This is the same property in which interest was devised to the grantor by Will of Grover C. Clark as will appear by reference to Apt. 1126, File 17 of the Probate Court of Greenville County and Deed recorded in Deed Book 907, page 358. Additional interest was acquired by deed dated December 11, 1970 recorded in Deed Book 907, page 355 of the RMC Office for Greenville County. Also, this being the same conveyance as made to Grantor by deed dated May 28, 1971 and recorded in the RMC Office for Greenville County in Book 916, page 89.
