KNOW ALL MEN BY THESE PRESENTS, that we, Hoover L. Lanier and Laura G. Lanier

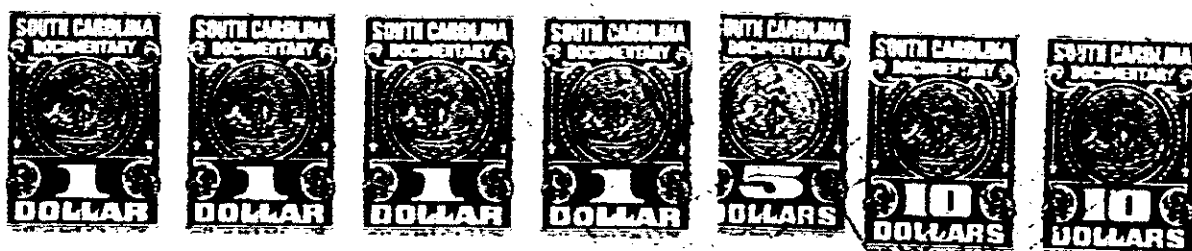
