ALSO: All that piece, parcel or lot of land in the City of Laurens, County of Laurens, State of South Carolina, and fronting on Street known as Washington Street. Said lot is bounded on Northwest by Two Hundred Sixty-Three and 6/10 (263.6) feet, more or less, by lots numbers 5 and 8 of Allen, on the Southeast for Two hundred sixty five (265) feet, more or less, by edge of former street line; and on Southwest for ninety (90) feet, more or less, by Washington Street. Watts on the 29th day of August 1934 by R. E. Babb, as Trustee, and Mrs. Sue A. Owings, by their deed duly recorded in the Office of the Clerk of Court for Laurens County in Deed Book 66, at page 381.

ALSO: All that piece, parcel or lot of land situate, lying and being in the County of Laurens, State of South Carolina, near the Corporate limits of the City of Laurens, containing one quarter of an acre (1/4), more or less, bounded on the Northeast by lot of Duke Power Company and Mrs. Emma Cooper, on the Southeast by lot of Mrs. Nora C. Bramlett, on the Southwest by Cora Street, and on the Northwest by lot of Mrs. Emma Cooper, and having the following courses and distances, to-wit: Commencing at iron stake on Cora Street, next to lot of Mrs. Emma Cooper, running thence North 37 degrees 15 minutes East 150 feet to iron stake, thence South 54 degrees East 75 feet to iron stake, thence South 37 degrees 15 minutes West 150 feet to iron stake on Cora Street, thence North 54 degrees West 75 feet to the beginning corner.
