KNOW ALL MEN BY THESE PRESENTS, that we, Ronald W. Johnston and Doris M. Johnston

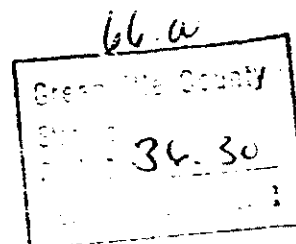
in consideration of Thirty-Three Thousand and No/100-----(\$33,000.00)-----Dollars,
