KNOW ALL MEN BY THESE PRESENTS that We, ERNEST G. FAULKNER & DOLLIE M. FAULKNER,

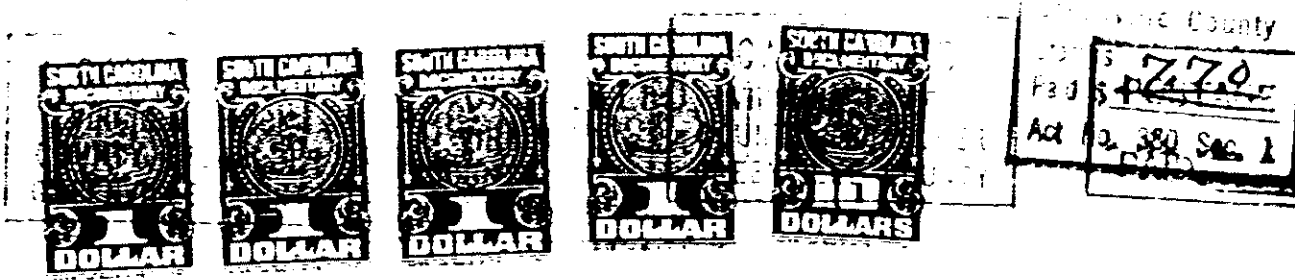
