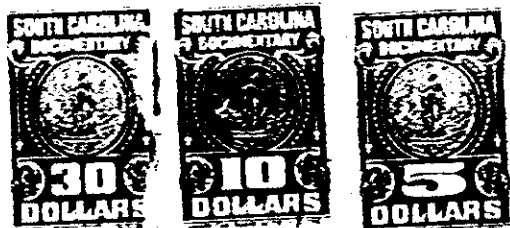
KNOW ALL MEN BY THESE PRESENTS, that **House Rentals, Inc.**
