

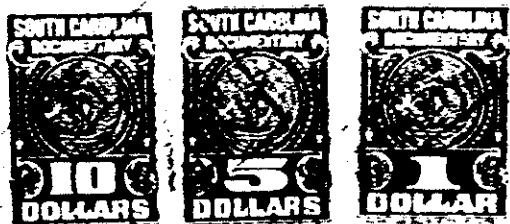
KNOW ALL MEN BY THESE PRESENTS, that A & B Properties, Inc.
