ALL that lot of land situate on the western side of Watson Road in Fairview Township, in Greenville County, State of South Carolina, being shown as Lot B on a plat of the Property of Mrs. Frank Davis, dated August 5, 1971, prepared by Webb Surveying and Mapping Company, recorded in Plat Book 5-A at Page 89 in the RMC Office for Greenville County, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin in Watson Road at the corner of Lot A and Lot B and running thence with Lot A, S 80-10 W 387.8 feet to an iron pin at the joint rear corner of Lot A and Lot B; thence S 2-08 E 958.4 feet to an iron pin at the joint rear corner of Lot B and Lot C; thence with Lot C, N 80-10 E 516.2 feet to an iron pin at the joint front corner of Lot B and Lot C; thence with Watson Road, N 9-50 W 949.4 feet to the point of beginning, and containing 9.9 acres.
