All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southwestern side of Richbourg Drive, near the City of Greenville, County of Greenville, State of South Carolina, in Chick Springs Township being known and designated as a portion of Lot No. 1 as shown on plat entitled "Property of Fred Soentgen" dated November, 1950, prepared by Dalton & Neves, R.S., and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book T at page 317, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southwestern side of Richbourg Drive at the joint front corner of Lots Nos. 1 and 2 and running thence with the line of Lot No. 2, S. 42-56 W. 200 feet to an iron pin; thence a new line through Lot No. 1, N 50-40 W. 111.5 feet to an iron pin in the line of Tract No. 14; thence with the line of Tract No. 14, N. 43-00 E. 200 feet to an iron pin on the Southwestern side of Richbourg Drive at the joint front corner of Tract No. 14 and Lot No. 1; thence with the Southwestern side of Richbourg Drive S. 50-40 E. 111.5 feet to the point of BEGINNING and being the same property conveyed to Grantor by Deed of Duke Power Company, dated April 2, 1973, and recorded in Deed Book 971 at page 557 of the Office of the R.M.C. for Greenville County.
