in consideration of eight hundred fifty and no/100 ----- Dollars,

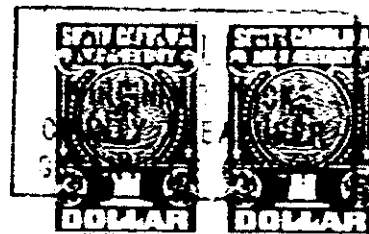
