ALL water lines, mains, valves and appurtenances installed and located in, under or along Sugar Creek Road, Silver Creek Lane, Sugar Lake Court, Stone Ridge Road, Middle Brook Road, Meadow Creek Court, White Water Court, Oak Ridge Court, Grey Stone Court and Stone Ridge Court, County of Greenville, State of South Carolina, including approximately 4,640 feet of 8" pipe; 3,400 feet of 6" pipe, 3,860 feet of 2" pipe, 6 - 8" valves, 15 - 6" valves, 27 - 2" valves and 11 fire hydrants, and is shown on a drawing entitled "John C. Cothran Co., Inc., Ellis L. Darby, Jr. and M. Graham Proffitt, III to Commissioners of Public Works of the City of Greenville, S. C.", dated November 29, 1974, attached hereto and made a part of this conveyance.
