ALL that piece, parcel or lot of land, together with all buildings and improvements, situate, lying and being on the western side of Iverson Street, in Greenville County, South Carolina, being shown and designated as Lot No. 1 on a plat of HERITAGE HILLS, SECTION 2, recorded in the RMC Office for Greenvi-le County, S. C., in Plat Book WWW, page 15, and having according to said plat the following metes and bounds, to-wit:
