KNOW ALL MEN BY THESE PRESENTS That I, Mallie K. Moon

in the State aforesaid, in consideration of the sum of One (\$1.00) Dollar and love  
and affection Dollars

to me in hand paid at and before the sealing of these presents  
by F. O. Moon

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by  
these presents do grant bargain, sell and release unto the said F. O. Moon and his  
heirs and assigns an undivided one-half interest:

all that piece, parcel or lot of land in Glassy Mountain Township, Greenville,  
County, State of South Carolina, lying on the west side of the Glassy Mountain  
Road, about one mile south from the Glassy Mountain Baptist Church,  
being a tract of land which F.O. Moon had exclusive possession for  
several years, and having the following courses and distances:

BEGINNING at an iron pin in the Glassy Mountain Road, corner with  
tract conveyed to F. O. Moon by G.V. Smith and on line of James A.  
Howard (Perry) land, and runs thence with the old G.V. Smith line, N.  
32-15 W. 1040 feet to an iron pin; thence N. 60-45 E. 190 feet to an  
iron pin in the Glassy Mountain Road; thence along and with the center  
of said road and line of James A. Howard (formerly Perry) in a southerly  
direction to the beginning corner, containing 4 acres.

ALSO, ALL that other parcel or tract of land lying near or adjoining  
that above described, in Glassy Mountain Township, Greenville County,  
State of South Carolina, and having the following courses and distances:

BEGINNING on an iron pin in the Glassy Mountain Road, and running  
thence with said road, N. 31 W. 63 feet to a point in said road; thence  
N. 55-30 W. 132 feet to a stake in the field; thence N. 37 W. 87 feet  
to a stake in the field; thence N. 14-45 W. 96 feet to a stake in field;  
thence N. 26 W. 91 feet to a stake in field; thence N. 12-30 W. 173  
feet to an iron pin; thence S. 73-15 W. 244 feet to a stake in a branch  
thence down and with the branch as follows: S. 36-00 E. 79 feet to a  
stake; S. 4-00 E. 74 feet to stake; S. 27-30 W. 50 feet to stake; S.  
10-45 E. 27 feet to stake; S. 18-00 W. 125 feet to stake; S. 39-30 E.  
60 feet to stake; S. 7-30 E. 133 feet to stake; S. 4-00 E. 76 feet to  
stake; S. 15-00 E. 132 feet to stake; thence down branch approximately  
120 feet to corner in branch (now or formerly James Howard); thence  
continuing with branch, S. 30-00 E. 336 feet to stake; S. 13-00 E. 67  
feet to a stake; S. 56 E. 109 feet to stake; S. 26-30 E. 257 feet to  
stake; S. 20-00 E. 298 feet to stake and S. 46-30 E. 330 feet to stake  
in the branch in the Glassy Mountain Road; thence with said road as  
follows: N. 4-00 W. 182 feet to bend; N. 8-00 E. 380 feet to iron pin in  
the said road; thence N. 32-15 W. 1040 feet to an iron pin; thence N.  
60-45 E. 190 feet to the beginning corner, containing 15.00 acres, more
