and release unto WILLIAM HOWARD HENLEY, individually and to SALLY JAMESON HENLEY,
as Trustee under Trust Agreement for JAMES JAMESON HENLEY dated August 7, 1974,
their heirs and assigns forever:

An undivided one-half (1/2) interest (being my remaining interest) in and to that
piece, parcel or lot of land, with the improvements thereon, situate, lying and being on
the Eastern side of New Buncombe Road near the City of Greenville, in the County of
Greenville, State of South Carolina, and known and designated as Lot 4, Section 2, as
shown on a plat entitled "Subdivision of Village Houses, F. W. Poe Mfg. Co., Greenville,
S. C.," made by Dalton & Neves July, 1950, and recorded in the R. M. C. Office for
Greenville County in Plat Book Y, at pages 30 and 31, and having according to said plat
the following metes and bounds:

BEGINNING at an iron pin on the Eastern side of New Buncombe Road, which iron
pin is S. 0-17 W. 150 feet from the Southeastern corner of the intersection of New Buncombe
Road and Locust Street, and running thence N. 89-45 E. 152 feet to an iron pin on the
Western side of a 10 foot alley; thence along the Western side of said 10 foot alley S. 0-17
W. 50 feet to an iron pin; thence S. 89-45 W. 152 feet to an iron pin on the Eastern side of
New Buncombe Road; thence along the Eastern side of New Buncombe Road N. 0-17 E.
