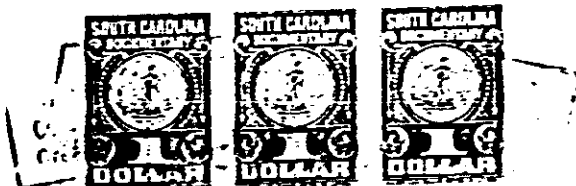
KNOW ALL MEN BY THESE PRESENTS, that I, Estell H. Brown,

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Great Township, in the Washington Baptist Church community, lying on the east side of the Cannon Road, being bounded on the south by the Weaver lot, on the west by the said road, and on the north and east by lands of Hattie V. Henderson, and being the same lot conveyed to me this day by deed from Hattie V. Henderson, and having the following courses and distances, to wit:-

Beginning on an iron pin on the west margin of the said road, joint corner of the Weaver lot, and runs thence with the common line of the Weaver lot and of this lot, N. 86-00 E. 25 feet to an iron pin on the east margin of the road, then continuing with the same course for a total distance of 552 feet to an iron pin, joint corner of the Weaver lot; thence N. 7-20 E. 161.2 feet to an iron pin; thence S. 86-00 W. 552 feet to a stake on the west margin of the said Cannon Road (iron pin back on line at 25 feet), containing Two (2) acres, more or less.
