All that piece, parcel or lot of land in Grove Township, County of Greenville, State of South Carolina, about 11 miles south of Greenville Courthouse, having the following courses and distances according to plat of C. O. Riddle, dated November 1974, designated property of Clara S. Henderson Est.:

Beginning at an iron pin on the east side of South Carolina Road 50; thence N. 88-00 E. 235 feet to an iron pin; thence N. 85-52 E. 1228.2 feet to an iron pin; thence N. 8-26 E. 643.8 feet to an iron pin; thence N. 42-11 E. 264 feet to an iron pin in creek; thence N. 37-47 W. 36.9 feet to an iron pin; thence S. 44-41 W. 1180.2 feet to an iron pin; thence S. 84-07 W. 881.9 feet to an iron pin on said South Carolina Road 50; thence S. 3-11 W. 29.5 feet to the point of beginning, containing 6.50 acres.
