KNOW ALL MEN BY THESE PRESENTS, that THE AMERICAN CANCER SOCIETY, SOUTH CAROLINA DIVISION, INC., SOUTH CAROLINA HEART ASSOCIATION and THE GREENVILLE COUNTY CANCER SOCIETY

in consideration of NINE THOUSAND FIVE HUNDRED TEN AND NO/100 (\$9,510.00) Dollars.

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto JOHN BERRY, D.M.D., P.A., his heirs and assigns forever:

ALL that piece, parcel or lot of land lying, being and situate in the County of Greenville, State of South Carolina, in the Town of Fountain Inn, being shown and designated as Lot 1 on a plat entitled "Property of Lurea M. Drummond" dated October 9, 1951, prepared by W. J. Riddle, R.L.S., and being more particularly described in accordance with said plat, to-wit:

BEGINNING at an iron pin in the edge of North Main Street, said point being the joint corner with Lot No. 2 and running thence along the edge of Main Street S. 63-02 E. 148.2 feet to an iron pin; thence along the joint property line of H. N. Gault, S. 35-48 W. 145.1 feet to an iron pin; thence along the joint line of Lot No. 4, N. 63-02 W. 125 feet to an iron pin; thence along the joint property line of Lot No. 2, N. 26-33 E. 143.7 feet to the point of beginning.

LESS, HOWEVER, that previously conveyed to H. Murk Gault by deeds recorded in the RMC Office for Greenville County in Deed Book 755, at Page 145 and in Deed Book 982, at Page 221.

This being the same property which the Grantors herein received by Will of Louella G. Creuse duly probated in the Probate Court for the County of Greenville, and recorded in Drawer 1299, at File 13.

This property is conveyed subject to easements, rights-of-way and restrictions of record.

This deed conveys only the undivided one-fourth (1/4) interest of the American Cancer Society, South Carolina Division, Inc. The remaining three-fourths (3/4) interest is being conveyed by separate deeds executed by the South Carolina Heart Association and the Greenville County Cancer Society.
