unto PHYLLIS L. WOOTEN, HER HEIRS AND ASSIGNS FOREVER:

ALL that piece, parcel or tract of land in Saluda Township, Greenville County, South Carolina, containing fifty (50) acres, more or less, near the East side of Buncombe Road, branch waters of Saluda River, bounded on the South by lands now or formerly of W. R. Allen; on the East by lands now or formerly of Hicks, on the North by lands now or formerly of E. F. Bayne, on the West by Buncombe Road, being the same property conveyed to W. W. Putman by deed dated October 25, 1923, recorded in Book 92 at Page 106.
