KNOW ALL MEN BY THESE PRESENTS, that BLANCH FOSTER and FLOYD CHAPMAN, and BEULAH COBB

in consideration of TEN & 00/100 ----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto HELEN C. COBB, her heirs and assigns all that piece, parcel or lot of land in Glassey Mountain Township, Greenville County, State of South Carolina;

BEGINNING at an iron pin on the north margin of the road which leads from the head of Lake Lanier to Dark Corner, said iron pin being a corner of the Lake Lanier property, and runs from said iron pin with the line of the Lake Lanier sub-division North 21 degrees 15 minutes West 598 feet to a stake with a black gum pointer, corner of the W.A. Fisher Estate land; thence with four lines of the Fisher property as follows: North 89 degrees 45 minutes West 130 feet to a stake; North 85 degrees 15 minutes West 236 feet to a stake; North 78 degrees 20 minutes West 223 feet; North 74 degrees 30 minutes West 44 feet to a stake with a Chestnut Oak pointer, corner of the J. Roy Pennell property; thence with the Pennell line South 592 feet to an iron pin by a pine on the north margin of the abovementioned road; thence along the north margin of said road South 79 degrees East 563 feet; South 85 degrees East 100 feet; North 69 degrees 15 minutes East 200 feet to the place of beginning, containing 10 acres, more or less. Being the identical property which was conveyed to me by E. G. Ballew.

There is excepted from the above property that portion containing 1.19 acres conveyed to C. Fred Hill and Gladys B. Hill by Floyd L. Cobb and Helen C. Cobb, dated June 15, 1957.

The interest of the above Grantors that is conveyed by this deed is as follows: A 1/4 interest by Beulah Cobb and a 1/16 interest by Blanch Foster and Floyd Chapman.
