the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Alice Patterson Pepper, her heirs and assigns, forever:

All that lot of land in the State of South Carolina, County of Greenville, being known and designated as the property of Frances H. Ball, according to a plat made by J. C. Hill in September, 1958, containing 1.94 acres, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the western side of a county road at the joint front corner of property now or formerly of R. V. Thompson and running thence with said Thompson line N 86-02 W 204.5 feet to an iron pin; thence S 80-58 W 203.6 feet to an iron pin in line of property now or formerly of James M. Hewitt; thence with Hewitt property S 12-22 W 135 feet to an iron pin; thence N 66-10 E 55 feet to an iron pin; thence S 83 E 48 feet to an iron pin; thence S 56-30 E 86 feet; thence S 77-10 E 275.5 feet to an iron pin; thence N 2 W 250.7 feet to the point of beginning.

ALSO: All that piece, parcel or tract of land situate, lying and being in the County of Greenville, State of South Carolina, containing 1.29 acres as shown on plat of property of Frances H. Ball prepared by J. C. Hill dated September 27, 1958, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin in the line of property heretofore conveyed by the grantee to Henry Miller and running thence S 12-22 W 204 feet to an iron pin; thence N 82-33 E 492 feet to an iron pin; thence N 2 W 34.5 feet to an iron pin; thence along the line of said Miller property N 77-10 W 275.5 feet to an iron pin at walnut; thence N 56-30 W 86 feet to an iron pin; thence 83 W 48 feet to an iron pin; thence S 66-10 W 55 feet to the point of beginning.

ALSO: Any easement or right of way Frances H. Ball might have across the 1.94 acres of land conveyed by Frances H. Ball to Henry Miller in Deed Book 609, at Page 196, or any right to use the spring thereon.

This conveyance is made subject to all restrictions, set back lines, roadways, easements and rights of way, if any, appearing of record, on the premises or on the recorded plat, which affect the property hereinabove described. (over)
