the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain,
sell and release unto Carl V. Schmidt and Joye R. Schmidt, their heirs and assigns
forever.

All that piece, parcel or lot of land with all improvements thereon, located,
lying and being in the County of Greenville, State of South Carolina, lying
and being at the intersection of Del Norte Road and Del Norte Boulevard, and
being known and designated as Lot 96 on a plat of Del Norte Estates, Section
4, recorded in the RMC Office for Greenville County in Plat Book 4N at Page 8,
and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the northern side of Del Norte Road at the joint front
corner of Lots 96 and 97 and running thence N. 5-25 E. 140.0 feet to a point
