in consideration of Fifteen Thousand and no/100-----Dollars,

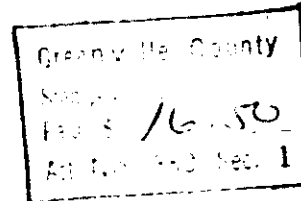
