ALL that certain piece, parcel or lot of land with buildings and improvements thereon in Paris Mountain Township, Greenville County, State of South Carolina, on the Southwest side of the Greenville-Hendersonville Highway and having the following metes and bounds, to-wit:

BEGINNING at a stone on road and running thence North 62 1/2 East 7.39 to center of road; thence S. 54 to center of new road; thence South 25 West 6.90 to stone on old road; thence N. 38 West 2.56 to the beginning point and containing 1.83 acres, more or less, adjoining lands to P. C. Marchbanks, E. E. Phillips and others.
