KNOW ALL MEN BY THESE PRESENTS that I, We, ROBERT L. MANN and LORA F. MANN of the County of GREENVILLE in the State aforesaid, in consideration of the sum of One Dollar (\$1.00) and other valuable consideration to US in hand paid by the United States of America, acting through the Administrator of the Farmers Home Administration, the receipt of which is hereby acknowledged, have granted, bargained, sold and released and by these presents do grant, bargain, sell and release unto the said United States of America, the following described property situated in GREENVILLE County, State of South Carolina, to-wit:

ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, and being known and designated as Lot No. 26, Bellingham, Section No. One, and having, according to a plat prepared of said Subdivision by Piedmont Engineers and Architects, as recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 4N, at Page 22, the following courses and distances, to-wit:

BEGINNING at a point on the edge of Abbotsford Drive, joint front corner of Lots Nos. 25 and 26, S. 82-48 E. 150 feet to a point; thence, S. 7-12 W. 80 feet to a point; thence, N. 82-48 W. 150 feet to a point on the edge of Abbotsford Drive, thence running with said road, N. 7-12 E. 80 feet to a point, the point of beginning.
