It is the intention of the parties hereto that the quitclaim of the interest of Tennessee Ravenwood Properties, Inc. in the above described property will terminate that certain Lease dated as of March 26, 1964, between Tennessee Ravenwood Properties, Inc., as Lessor, and GENESCO Inc., as Lessee, Memorandum of which Lease is recorded in Deed Book 745, page 471, of the records in the office of the Register of Conveyances of Greenville County, South Carolina, insofar as, and only insofar as, said Lease covers the property herein described.

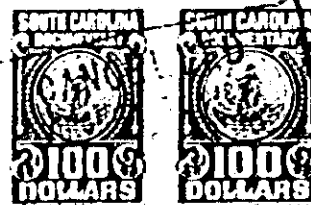
