The aforementioned 11.73 acres was conveyed to the Grantor herein by deed of R.M. Caine dated August 1, 1938, and recorded in the RMC Office for Greenville County, South Carolina, in Deed Book 205, at Page 67.

ALSO, ALL that piece, parcel or lot of land situate, lying and being in Greenville Township, Greenville County, State of South Carolina, in the Subdivision known as Addition #2 to Forest Hills, on the North side of Forest View Drive, and being more particularly described as follows:

BEGINNING at an iron pin in the Southwest corner of other property coming to the Grantor by R.M. WHEREAS, the above mentioned deed from me to Christ Church contains the following provisions:

In accepting the title to the premises herein described, the Grantee agrees that if within three (3) years after the death of the Grantor, the above described property or the proceeds derived from the sale of same have not been turned over to or used in connection with the establishment of a Church related private High School located in Greenville County, South Carolina, that the Grantee shall convey the above described premises or transfer the proceeds derived from the sale there of without further consideration, to the Board of Trustees of Presbyterian College, Clinton, South Carolina, provided, however, that the foregoing conditions shall in no way restrict alienation of the premises herein conveyed to a bona fide purchaser for full and adequate consideration, nor shall said purchaser be required to see to the application of the proceeds pursuant to the conditions hereinabove stated.

WHEREAS, Christ Church, as a part of its operation, has established and is operating and maintaining a High School
