All that lot of land lying on the southern side of Crosby Circle, in Greenville County, South Carolina, near the City of Greenville, being shown and designated as Lot NO. 140 on plat of Paramount Park, recorded in the R. M. C. Office for Greenville County in Plat Book "W", at Page 57, and more particularly shown on plat of property of Jerry C. Tuck and Carol M. Tuck prepared by R. K. Campbell, dated September 9, 1965, and according to said plat, described as follows:

BEGINNING at an iron pin on the southern side of Crosby Circle, at the front corner of Lot No. 141, which pin is 920 feet northwest of the intersection of Crosby Circle with Dorr Drive; and running thence with the southern side of Crosby Circle, N. 64-00 E. 70 feet to an iron pin at the front corner of Lot No. 139; thence S. 26-00 W. 70 feet to an iron pin at the rear corner of Lot No. 141; thence with the line of said Lot N. 26-00 W. 150 feet to the beginning corner.

Office for Greenville County in Deed Book 404, at Page 479.
