KNOW ALL MEN BY THESE PRESENTS, that we, J. C. Cox, Jr. and Calvin N. Cox

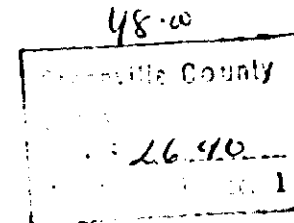
in consideration of Twenty-Four Thousand and No/100-----(\$24,000.00)----- Dollars,
