release unto ARTISTIC BUILDERS, INC. its successors and assigns forever:

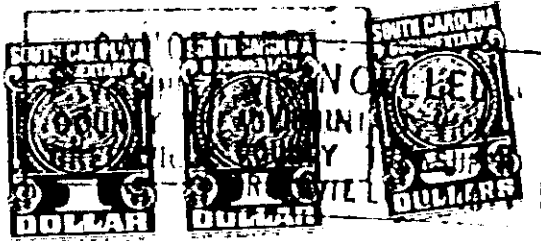
All that certain piece, parcel or lot of land, situate, lying and being in the Town
