

KNOW ALL MEN BY THESE PRESENTS, that I, Frances M. Ferguson, now Frances M. Poole

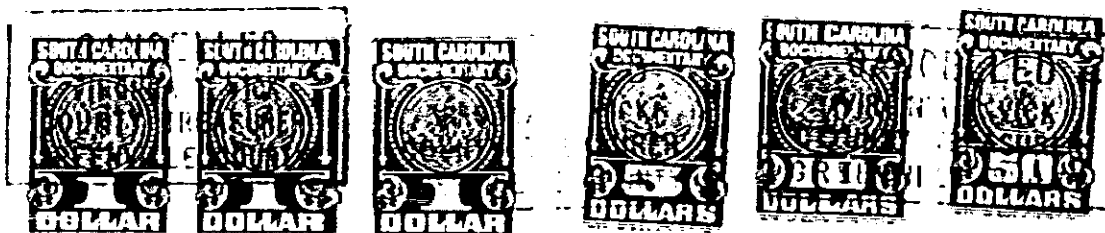
