CORRECTION DEED

All that piece, parcel or lot of land situate, lying and being at the southwestern corner of the intersection of Sheffield Drive and Knight Place near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 23 as shown on a plat of Canterbury Subdivision, Section I, Revised, prepared by Heaner Engineering Co., Inc., dated September 26, 1972, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book 5-D at page 16, and having according to said plat the following metes and bounds:
