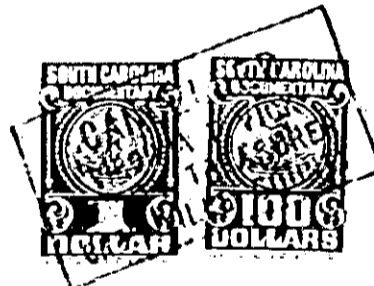
KNOW ALL MEN BY THESE PRESENTS, that CONSOLIDATED FREIGHTWAYS CORPORATION OF DELAWARE
