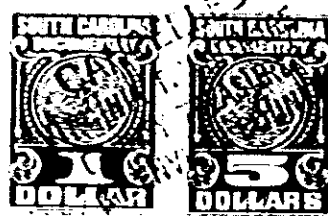
in consideration of Three Thousand and no/100 (\$3,000.00)----- Dollars,
