K. D. JONES AND JEANETTE JONES

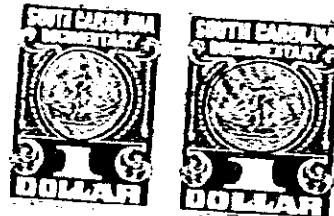
