

CARPENTER and CLEO W. CARPENTER, their heirs and assigns forever:

ALL that piece, parcel or lot of land, together with buildings and improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designated as a portion of Lot No. 46 on a Plat of Property of D. W. Cochrane, recorded in the RMC Office for Greenville County, South Carolina in Plat Book I, Pages 92 and 93 and having, according to a more recent plat entitled "Property of Marion Perry Greene, prepared by Carolina Surveying Co., May 29, 1972, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of Oakview Drive at the joint front corner of Lots Nos. 39 and 46 and running thence S. 52-04 E., 136 feet to an iron pin; thence S. 37-56 W., 10 feet to an iron pin; thence S. 52-04 E., 25 feet to an iron pin; thence S. 37-56 W., 60 feet to an iron pin at the joint rear corner of Lots Nos. 46 and 47; thence along the joint line of said lots, N. 52-21 W., 141.4 feet to an iron pin on the Southern side of Oakview Drive; thence with said Drive, N. 21-56 E., 72.8 feet to the point and place of beginning.

The above described property is the same property conveyed to the Grantor herein bydeed of William E. Berry, Jr., recorded in the RMC Office for Greenville County, South Carolina in Deed Book 946, Page 118, and is hereby conveyed subject to rights of way, easements, conditions, public roads, restrictions and other instruments of public record and actually existing on the ground affecting said property.
