the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Caroline E. Fore, her heirs and assigns forever

All that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, known and designated as Lot No. 36 of Stone Lake Heights, Section 1 on a Plat prepared by R. K. Campbell revised November 17, 1959, recorded in the R.M.C. Office for Greenville County in Plat Book IT at Page 93 and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the east side of Lakecrest Drive at the joint front corners of Lots 36 and 37 and running thence with the joint line of Lots 36 and 37, S. 73-34 E. 228.7 feet to an iron pin; thence S. 73-34E. 14.6 feet to a point on the edge of Stone Lake; thence with the lake shore S. 5-02 W. 77.7 feet to a point; thence N. 83-14 W. 9 feet to an iron pin; thence continuing with the joint line of Lots. Nos. 35 and 36 N. 83-14 W. 254 feet to an iron pin on the east side of Lakecrest Drive; thence N. 16-26 E. 102 feet to an iron pin; thence continuing with the east side of Lakecrest Drive. N. 16-26 E. 18 feet to the point of beginning.

The Grantor also grants any and all riparian privileges or any other rights, easements or privileges granted to E.M. West by deed of Reid A. Powe, recorded in the Office of the R.M.C. for Greenville County in Deed Book 625 at page 20.
